ADDITIONAL INFORMATION:

- Residents are responsible for checking their student accounts online around the 5th of each month for charges, statements are not provided. Unpaid balances as of the 1st of the month are considered past due, and will be assessed interest at the rate of 1% per month (12% APR). You are responsible for paying fees by the deadline even if you do not receive a bill.
- Make your payments online or at the cashier's office in Kerr Administration Building.
- Charges begin on September 25, 2022. Students who cancel before this date are assessed a cancellation fee per Section 7 of UHDS contract.
- Term and annual rates are calculated based on the days of occupancy. Vacation break periods are included at no extra charge.
- There is an \$20.00 per term fee (\$60 for the year) associated with operating the Residence Hall Association (RHA) incorporated in each room rate.

UHDS Dining Plan Dollars give you the flexibility to eat at any of more than 30 dining locations on campus. When spending UHDS Dining Plan Dollars at dining center locations, you will receive a 20% discount on your meal. At other UHDS-managed locations, you will receive a 10% discount. Orange Cash funds can be used in all UHDS- or Memorial Union-managed campus dining locations with a 10% point of sale discount. There are no dining plan or Orange Cash discounts on robot food delivery or mobile orders. Students may add money to their Orange Cash account via the MyCard website or in person at the OSU ID Center. UHDS Dining Plan Dollars are non-refundable; see UHDS contract for details on potential "roll over" of remaining dining plan balances at the end of the contract period. Campus residents are responsible for monitoring their UHDS Dining Plan balances each term. It is the resident's responsibility to change to a lower plan via MyUHDS if they want to within the first 3 weeks of each term. Residents can increase their dining plan at any time.

To appeal any charges for Housing and Dining, please submit a Petition of Financial Appeal via your MyUHDS.

Please keep in mind the petition must be submitted within 45 days of the original charge and documentation will need to be provided relevant to the case.

Charges can't be appealed that have not been placed on an account. The committee will meet within 30 days of submitted petitions and will render their decision after the meeting via ONID email.
