Orange Cash can be used in all campus dining locations with a 10% point of sale discount. Students may add money to their Orange Cash via their MyCard Account. UHDS Dining Dollars are non-refundable; see UHDS contract for details on potential "roll over" of remaining dining plan balances at the end of the contract period. Residents are responsible for monitoring their UHDS Dining Plan balances each term. If the dining plan provides more than is needed, it is the resident's responsibility to change to a lower plan.
